Scrutineers for and against Bylaw No. 435 must be appointed, if applications are received from persons who qualify to vote and who wish to volunteer as scrutineers.

You are qualified to vote on this question if you meet the following requirements on July 17, 2010:

- You are 18 years of age or older;
- You are a Canadian citizen;
- You have been a resident of BC for at least 6 months; and
- You have been a resident of or owned property in Electoral Area A, B, C or D for at least 30 days; and
- You are not otherwise disqualified from voting.
