BYLAW NO. 192

Being a bylaw to provide for the imposition of a charge against
the owner or occupier of real property for the use of the Lund
Sewer System


The Board of the Powell River Regional District, in open meeting
assembled, enacts as follows:

1. There is hereby imposed and levied a sewer user charge
against owner or occupier of land or real property whose
property is connected to the Lund sewer system and the clerk
shall classify each consumer in accordance with the
categories set out in Schedule "A", attached to and forming
part of this bylaw.
2. The rates shall be due and payable quarterly on March 31st,
June 30th, September 30th, and December 31st at the office of
the Powell River Regional District.
3. In the case of a connection being made during any year, the
charge imposed shall begin with the month during which the
final inspection of the sewer connection was made. If made on
or before the 15th day of the month, the full monthly rate
shall be charged, otherwise the charge shall be one-half of
the monthly charge.
4. Any rate remaining unpaid on the thirty-first of December
shall be deemed to be taxes in arrear on the property
concerned and shall be forthwith entered on the real property
tax roll by the Collector as taxes in arrear.
5. This bylaw may be cited as the "Lund Sewer User Rates Bylaw
Number 192, 1990".



The Regional Board of the Powell River Regional District, in open meeting assembled, enacts as follows:






